Biden sends top adviser for talks on Israel-Saudi normalization

Washington: President Joe Biden dispatched his national security adviser Jake Sullivan to Saudi Arabia on Thursday for talks with the kingdom's de facto leader Crown Prince Mohammed bin Salman as the White House pushes for a normalization of relations between the country and Israel.

The White House in a brief statement said that Sullivan arrived in Jeddah on Thursday for talks with the crown prince, who is often referred to by his initials MBS, and other Saudi officials. The wide-ranging talks covered initiatives to "advance a common vision for a more peaceful, secure, prosperous, and stable Middle East," and efforts to find a permanent end to the years-long conflict between the Saudis and Iran-allied Houthis in Yemen, according to the White House.

Sullivan and MBS also discussed the Biden administration's hopes to normalize relations between Israel and Saudi Arabia, according to a White House National Security Council official familiar with the matter. The official was not authorized to comment publicly and spoke on the condition of anonymity.

Donald Trump accused of deleting camera footage

Donald Trump faces new charges in the classified documents case that accuse him of asking a staffer to delete camera footage at his Florida in an effort to obstruct the federal investigation into his possession of the records, according to an updated indictment unsealed Thursday.

The indictment includes new counts of obstruction and willful retention of national defense information, compounding Trump's legal jeopardy even as he braces for a possible additional indictment in Washington over his efforts to overturn the results of the 2020 presidential election. The additional counts underscore the extent of the yearlong investigation into Trump that first produced charges last month in the form of a 38-count indictment against Trump and his valet Walt Nauta. Surveillance footage at the Mar-a-Lago complex has long been central to the investigation because, according to prosecutors, it showed Nauta moving boxes of documents in and out of a storage room — including such action one day before a visit by FBI and Justice Department officials.

A Trump spokesperson dismissed the new charges as "nothing more than a continued desperate and flailing attempt" by the Biden administration "to harass President



Trump and those around him" and to influence the 2024 presidential race.

The updated allegations in the indictment center on surveillance footage at Trump's Mar-a-Lago estate in Palm Beach. Trump is alleged to have asked to have the footage deleted after FBI and Justice Department investigators visited in June 2022 to collect classified documents that he took with him after leaving the White House a year earlier. Law enforcement officials issued a subpoena for the footage after noticing surveillance cameras while they were there. The indictment quotes a Mar-a-Lago property manager, Carlos De Oliveira, telling a colleague that the "boss" wanted a server hosting the footage to be deleted. It says De Oliveira went to the IT office last June, took an employee to a small room known as the "audio closet" and asked the

person how many days the server retained footage.

When the employee said he didn't believe he was able to delete footage, De Oliveira insisted the "boss" wanted it done, asking, "What are we going to do?"

De Oliveira was added to the indictment, charged with obstruction and false statements related to an interview he gave the FBI earlier this year.

The superseding indictment charges Trump with an additional count of willfully retaining national defense information, relating to a July 2021 interview at his Bedminster, New Jersey, golf club in which the former president discussed U.S. military plans to attack another country. The interview was for a memoir being written by his onetime chief of staff, Mark Meadows, who in his subsequent book named the country as Iran. According to the indictment, Trump returned that document, which was marked as top secret and not approved to show to foreign nationals, to the federal government on Jan. 17, 2022. It marks a notable shift in the prosecution's approach to Trump's case, charging him for retaining a document it alleges the former president knew was highly sensitive after he left office — and not just for failing to return it to the government when asked.

Philippine ferry flips over, 27 die

The skipper of a Philippine ferry which flipped over in a lake in an accident that killed 27 passengers decided to sail despite knowing that his boat was filled beyond capacity, the coast guard chief said Friday.

Forty-three passengers were rescued after the M/B Aya Express capsized in Laguna de Bay on Thursday shortly after leaving Binangonan town southeast of Manila in what should have been a 30-minute cruise to nearby Talim Island, officials said.

Coast guard, police and other government personnel continued to search the lake Friday but said they had no idea whether anyone was still missing because of uncertainties over the number of passengers on the ferry. No more survivors or bodies were found.

Two coast guard inspectors allowed the ferry to sail after being shown a manifest which listed only 22 passengers in addition to the boat's three-member crew, coast guard chief Admiral Artemio Abu said at a news conference. The two inspectors were removed from their post and will be investigated, coast guard officials said. They said the skipper and the two other crew members and the boat owner may face criminal complaints.

Sea accidents are common in the Philippines because of frequent storms, poorly maintained boats, overcrowding and weak enforcement of safety regulations. In December 1987, the ferry Dona Paz sank after colliding with a fuel tanker, killing more than 4,300 people in the world's worst peacetime maritime disaster.

The Aya Express had a capacity of 42 passengers, the coast guard said. Under questioning by authorities, the skipper acknowledged that the ferry had exceeded its passenger capacity when it left port, Abu said. The skipper said only 22 passengers were aboard the ferry at first but the number swelled when more people despatched for a ride arrived.

'US against China's bullying behaviour'

US Defence Secretary Lloyd Austin said Friday the United States stands with countries fighting Chinese "bullying behavior" as he launched bilateral talks in Australia aimed at countering Beijing's growing influence in the Indo-Pacific region. Austin and US Secretary of State Antony Blinken arrived in the Australian city of Brisbane late Thursday ahead of annual bilateral meetings on Friday and Saturday that will focus on a deal to provide Australia, a defense treaty partner, with a fleet of submarines powered by U.S. nuclear technology.

Ahead of a meeting with Australian Defence Minister Richard Marles, Austin said both countries share concerns about China's break from international laws and norms that resolve disputes peacefully and without coercion. "We've seen troubling P.R.C. coercion from the East China Sea, to the South China Sea, to right here in the Southwest Pacific," Austin told reporters, referring to the People's Republic of China. "We'll continue to support our allies and partners as they defend themselves from bullying behavior," he added.

China has imposed a series of official and unofficial trade barriers in recent years against Australian exports including coal, wine, barley, beef, seafood and wood. The barriers are widely seen as a punitive reaction to Australian government policy that has cost Australian exporters as much as \$15 billion a year.

Australia's icy relationship with Beijing was thawing since a change of Australian government at elections last year. Meanwhile, the sharing of US nuclear

secrets with Australia takes that bilateral relationship to a new level.

Prime Minister Anthony Albanese is planning state visits to both the United States and China before the end of the year. Under the AUKUS partnership — an acronym for Australia, the United Kingdom and the United States — Australia will buy three Virginia-class submarines from the United States and build five of a new AUKUS-class submarine in cooperation with Britain. Australian media have focused on a letter signed by more than 20 Republican lawmakers to President Joe Biden that warned the deal would "unacceptably weaken the US fleet" without a plan to boost US submarine production.

China will strengthen global partnerships: Wang

China's Foreign Minister Wang Yi, who replaced Qin Gang this week after his summary dismissal, has said in his first comments that Beijing would deepen its global partnerships while resolutely safeguarding its sovereignty, security and development interests.

Significantly, the Chinese Foreign Ministry, which scrubbed the name, photos and speeches of Qin soon after his sacking on Tuesday, restored them on Friday.

Soon after China's Parliament, the National People's Congress (NPC), passed a resolution sacking Qin, 57, and re-appointed director of the ruling



Communist Party's Foreign Affairs Commission Wang, 69, as the foreign minister, all references to Qin were scrubbed out by the foreign ministry on Wednesday.

However, within two days, the content of Qin's engagements during his six-month stint as the foreign minister has been reloaded on the official

Chinese website of the ministry. Asked about Qin's records reappearing on the website, the ministry urged the media not to "over-decode" the information.

"We have taken notice that the (foreign ministry) website has been updated. It's normal to update information. You don't have to over-decode our information," the Hong Kong-based South China Morning Post quoted spokeswoman Mao Ning as saying on Friday.

Wang, in his first comments after being re-appointed as China's foreign minister, said China, under the leadership of President Xi Jinping, will deepen and expand global partnerships with win-win cooperation. At the same time, China

will resolutely defend its national sovereignty, security and development interests and fully protect the legitimate rights and interests of Chinese citizens overseas, he said in a message posted on the Chinese Foreign Ministry website.

While Qin was the foreign minister, he still had to answer to Wang, who as the head of the Communist Party's foreign affairs commission occupied the top diplomatic position in China's party-centric power hierarchy. Wang has now taken on Qin's job. Qin was made the foreign minister in December last year, superseding many seniors and earning the distinction of being a rising star in the ruling Communist Party of China (CPC). He was one of the

youngest appointees to the post in China's history. Before his elevation, Xi had sent Qin as China's ambassador to the US to stabilise Beijing's stalled ties with Washington. No reason has yet been given for Qin's sacking nor his whereabouts are known yet. The high-profile minister has not been seen in public since June 25, after he met with officials from Sri Lanka, Vietnam, and Russia here. Wang returns to a post he held for most of the past decade. From 2004 to 2007, he served as China's ambassador in Tokyo. Interestingly, Wang met India's National Security Advisor Ajit Doval this week in Johannesburg on the sidelines of the meeting of NSAs of the BRICS grouping.

'Second lottery round for H-1B applicants to be conducted this year'

A second round of random lottery selection for the much sought-after H-1B visas for fiscal 2024 will soon begin after it was determined that "additional registrations" need to be selected to reach the numerical allocations, the US federal immigration agency has announced, a decision that could benefit more Indian professionals. The US Citizenship and Immigration Services (USCIS) said on Thursday that it will select the additional registrations from the previously submitted electronic registrations using a random selection process.

In March, the USCIS conducted an initial random selection of properly submitted electronic registrations for the fiscal year (FY) 2024 H-1B cap, including for beneficiaries eligible for the advanced degree exemption.

Only those petitioners with selected registrations for FY 2024 are eligible to file H-1B cap-subject petitions. The initial filing period for those with selected registrations for FY 2024 was from April 1, 2023, through June 30, 2023. The H-1B visa is a non-immigrant visa that allows US companies to employ foreign workers in speciality occupations that require theoretical or technical expertise.

Technology companies depend on it to hire tens of thousands of employees each year from countries like India and China.

पुलिस और एटीएस की लंबी पूछताछ के बाद भी सीमा-सचिन की प्रेमकथा एक अनसुलझी कहानी बनी हुई है। हालांकि एजेंसियों की ओर से जांच जारी है। अभी तक कि जांच में भले ही कुछ खास हाथ नहीं लगा हो लेकिन क्लोन चिट भी नहीं दी जा सकती।

वहीं केंद्रीय जांच एजेंसी अब दोनों से पूछताछ की तैयारी में हैं। जल्द ही एक्सपर्ट की टीम सीमा-सचिन के साथ उनके परिजनों और करीबियों से पूछताछ करेगी। हालांकि अभी बताया नहीं जा सकता कि सेंट्रल एजेंसी की पूछताछ सचिन के घर पर होगी या किसी अन्य स्थान पर इन्हें ले जाया जाएगा।

पूरे प्रकरण में जिस प्रकार जांच एजेंसियां उलझी हुई हैं उसे देखते हुए फिलहाल सीमा-सचिन पर मंडरा कंडेक्ट के वादल छड़ते नजर नहीं आ रहे। वहीं सीमा को डिपोर्ट करने की तैयारी की जा रही है। पाकिस्तान सरकार से



रिपोर्ट मिलते ही उस पर एक्शन लिया जाएगा। वहीं पुलिस ने सचिन के दो भाइयों को फर्जी आधार कार्ड मामले में गिरफ्तार किया है। एक आईआर में उसे सीमा और सचिन से नहीं जोड़ा गया है। यानी एटीएस और पुलिस दोनों भाइयों और सचिन से की गई पूछताछ को गोपनीय

रखना चाहती है। इसकी रिपोर्ट सेंट्रल एजेंसियां को दी जा रही है। यही कारण है कि सेंट्रल एजेंसियां सीमा और सचिन से पूछताछ कर सकती हैं। पुलिस को अब भी मोबाइल डेटा रिकवरी रिपोर्ट का इंतजार है। सीमा-सचिन की प्रेमकथा पर भले ही अब

मामला शांत पड़ गया है। लेकिन विभिन्न एजेंसियों द्वारा जांच के चलते सीमा-सचिन पुलिस सुरक्षा में ही रहना होगा। परिजनों व करीबियों की गतिविधियों पर भी कड़ी नजर रहेगी। किसी वक्त भी किसी से पूछताछ की जा सकती है। विगत दो दिन से

भले ही भीड़ भाड़ वाला माहौल सत्राटा में तब्दील हो गया है। अभी तक कि पूछताछ में जांच एजेंसियां किसी नतीजे पर नहीं पहुंच सकी हैं। लेकिन प्रकरण को गम्भीरता को देखते हुए पुलिस, एटीएस व केंद्रीय जांच एजेंसी कार्य कर रही हैं। सीमा-सचिन की मुश्किलें बढ़ने के संकेत मिल रहे हैं। सचिन के घर पर पुलिस बल तैनात किया हुआ है और लोगों को नजरों से बचाने के लिये हर रोज उनके रहने का स्थान बदल दिया जाता है। हालांकि की दावा किया जा रहा है कि गुपचुप तरीके से देर-सबेर कुछ लोग अभी भी मुलाकात कर रहे हैं।

पता चला है कि उस दिन उन दोनों ही जगहों से किसी भी थर्ड नेशन सिटिजन ने एंट्री नहीं ली है। केंद्रीय एजेंसियों की जांच में यह बात सामने आई है कि 13 मई को भारत-नेपाल सीमा सुनौली सेक्टर और सीतामढ़ी सेक्टर में किसी भी थर्ड नेशन सिटिजन की मौजूदगी की कोई जानकारी सामने नहीं आई है।

धर्मांतरण के मामले में पुलिस के रडार पर 12 लोग

खुफिया विभाग की कई टीम गांव में कर रही जांच

मोदीनगर में धर्मांतरण के मामले में पुलिस की रडार पर गांव शाहजहांपुर सहित अन्य गांवों के एक दर्जन से अधिक लोग रडार पर हैं।

धर्मांतरण के मामले में मुख्य आरोपी की गिरफ्तारी होने के बाद खुफिया विभाग की टीम ने क्षेत्र में डेरा डाल दिया है। खुफिया विभाग अब यह पता लगाने में जुटा है कि गांव शाहजहांपुर के अलावा और किन किन गांवों में धर्मांतरण किया गया है। गांव शाहजहांपुर में एक सप्ताह पूर्व धर्मांतरण कराने का आरोप लगाकर हिंदू युवा वाहिनी के कार्यकर्ताओं ने जमकर हंगामा किया था। उनका आरोप है कि लालच देकर हिंदू से इसाई बनाया जा रहा है। गांव शाहजहांपुर निवासी आशीष ने लालच देकर धर्मांतरण कराने का दावा डालने का आरोप लगाते हुए कुसुम के खिलाफ मोदीनगर थाने में रिपोर्ट दर्ज कराई थी। पुलिस ने जब रिपोर्ट दर्ज कर इस मामले में जांच शुरू की तो चौकाने वाली बात सामने आई। हापुड़ देहात के गांव सूदाना निवासी महेंद्र व उसकी पत्नी गौरा परिवारों को लालच देकर धर्म परिवर्तन कराते हैं। वे हापुड़ में वैद्यहलम गोस्वामि नाम से ट्रस्ट के

मध्यम से यह काम कर रहे हैं। ट्रस्ट को विदेशों से काफी फंडिंग भी हो रही है। इस खुलासे के बाद खुफिया विभाग की टीम ने गांव शाहजहांपुर सहित आसपास के गांवों में डेरा डाल दिया है। अब खुफिया विभाग यह पता लगाने में जुटा है कि क्षेत्र के कौन कौन से गांवों में किन किन लोगों ने धर्म परिवर्तन किया है। मोदीनगर तहसील क्षेत्र के गांव गांव में धर्मांतरण कराने वाला गिरोह सक्रिय है। वह आर्थिक रूप से कमजोर, बीमार व लापरवा लोगों को लालच देकर धर्म परिवर्तन करा रहे थे। सूत्रों से मिली जानकारी के अनुसार, अब तक सैकड़ों लोगों का धर्म परिवर्तन किया जा चुका है। जिन लोगों का धर्म परिवर्तन हुआ है, उन्होंने इस खुलासे के बाद चुप्पी साध ली है। एसीपी मोदीनगर ज्ञान प्रकाश राय का कहना है कि धर्मांतरण के मामले की जांच गहनता से की जा रही है।

बल तुरंत अपने संबंधित क्षेत्र के पुलिस उपायुक्त को रिपोर्ट करे। उल्लेख किए गए सभी विवेचनाओं की निगरानी एवं प्रशासनिक नियंत्रण का जिम्मा संबंधित जोन के पुलिस उपायुक्त पर होगा। महिलाओं से संबंधित मामलों की जांच और निपटान के लिए जिले के प्रत्येक थाने में तैनात पुलिसकर्मियों की एक इकाई स्थापित की गई थी, जिसे अब भंग कर दिया गया है। एक पुलिस अधिकारी ने बताया कि वे पुलिसकर्मी नोएडा के सेक्टर 108 में आयुक्तालय कार्यालय में पुलिस उपायुक्त की निगरानी में काम करते थे। पुलिस कमिश्नर ने निर्देश दिए हैं कि पुलिसकर्मियों अपने-अपने जोन के पुलिस उपायुक्त को रिपोर्ट करेंगे। संदर्भित विवेचना का पर्यवेक्षण तथा प्रशासनिक नियंत्रण संबंधित जोन के पुलिस उपायुक्त रहेगा। संभावना जताई जा रही है कि

नए सिरे से महिला सुरक्षा इकाई का गठन किया जाएगा और इस बार इकाई में उन पुलिस अफसरों को तैनाती दी जाएगी जो मामलों की समय से शिकायतों और विवेचनाओं का निस्तारण करेगी। पुलिस कमिश्नर लक्ष्मी सिंह को पिछले कुछ समय से महिला सुरक्षा इकाई द्वारा शिकायतों एवं विवेचना के निस्तारण में बरती जा रही लापरवाही को शिकायतों मिल रही थी।
